Road, Chinna Kolambakkam, Maduranthakam Taluk, Kancheepuram District - 603 103** for conducting the **BDS Degree Course** with an annual intake of **One Hundred (100) seats** from the academic year **2007-2008**.

2. In the reference 2<sup>nd</sup> cited, **Karpaga Vinayaga Institute of Dental Sciences, Kancheepuram District** has obtained the recognition order from the Under Secretary to Government of India, Dental Council of India/ Ministry of Health and Family Welfare, New Delhi to conduct **BDS Degree Course**.
