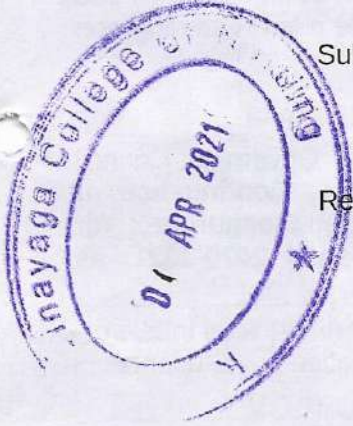

In the reference 2ndcited, the University has granted the Provisional Affiliation to Karpaga Vinayaga Educational Trust, Kancheepuram District to start B.Sc(N) Degree Course with an annual intake of 50 seats for the academic year 2010-2011.

In the reference 3rd cited, the Continuance of Provisional Affiliation was issued for B.Sc(N) Degree Courses with an annual intake of 50 seats for the academic year 2018-19.

In the reference 4th & 5th cited, Indian Nursing Council, New Delhi and Tamil Nadu Nurses and Midwives Council, Chennai has granted suitability & recognition to conduct B.Sc(N) degree Course with an annual intake of 50 seats for the academic year 2019-20.

In the reference 7th & 8th cited, Indian Nursing Council, New Delhi has published the list of State Nursing Council recognized Institutions offering B.Sc(N) Programme Inspected under Section 13 and 14 of INC Act and the Tamil Nadu Nurses & Midwives Council, Chennai has published the list of colleges of Nursing for B.Sc(N) Degree courses recognised for the academic year 2019-2020 & 2020-2021, wherein, Karpaga Vinayaga College of Nursing, Kancheepuram District has been granted suitability & recognition to conduct B.Sc (N) Programme with an annual intake of 50 seats for the academic year 2019-2020 and 2020-2021.

Due to Covid-19 Pandemic, the University inspection of the B.Sc(N) – 50 seats Degree Courses could not be conducted. Based on the Resolution No.4 (1) passed at the 277th Governing Council meeting held on 30.09.2020, the Managing Trustee has submitted a notarized affidavit duly signed by the Managing Trustee to abide by the appropriate rules regarding non conduct of regular inspection for the academic year 2020-2021.

ORDER:-

Based on the approval of relevant nursing council's and Governing Council resolution, the Tamil Nadu Dr. M.G.R. Medical University, Chennai grants **Continuance of Provisional Affiliation to Karpaga Vinayaga College of Nursing, Kancheepuram**, for conducting B.Sc.(N) Degree course for the academic year 2019-2020 and 2020-2021, as indicated below -

3. The admission procedure of the Government as per the scheme of admission enunciated by the Supreme Court of India should be followed.

4. The admission procedure as laid down in the G.O., of Health and Family Welfare Department, Chennai should be followed strictly. Any admission made over and above will not be permissible on any account.

5. The renewal of approvals from relevant Councils should be produced on expiry of their validity to consider further Continuance of Provisional Affiliation.

6. Any other condition which the University considers necessary to impose from time to time should be followed.
